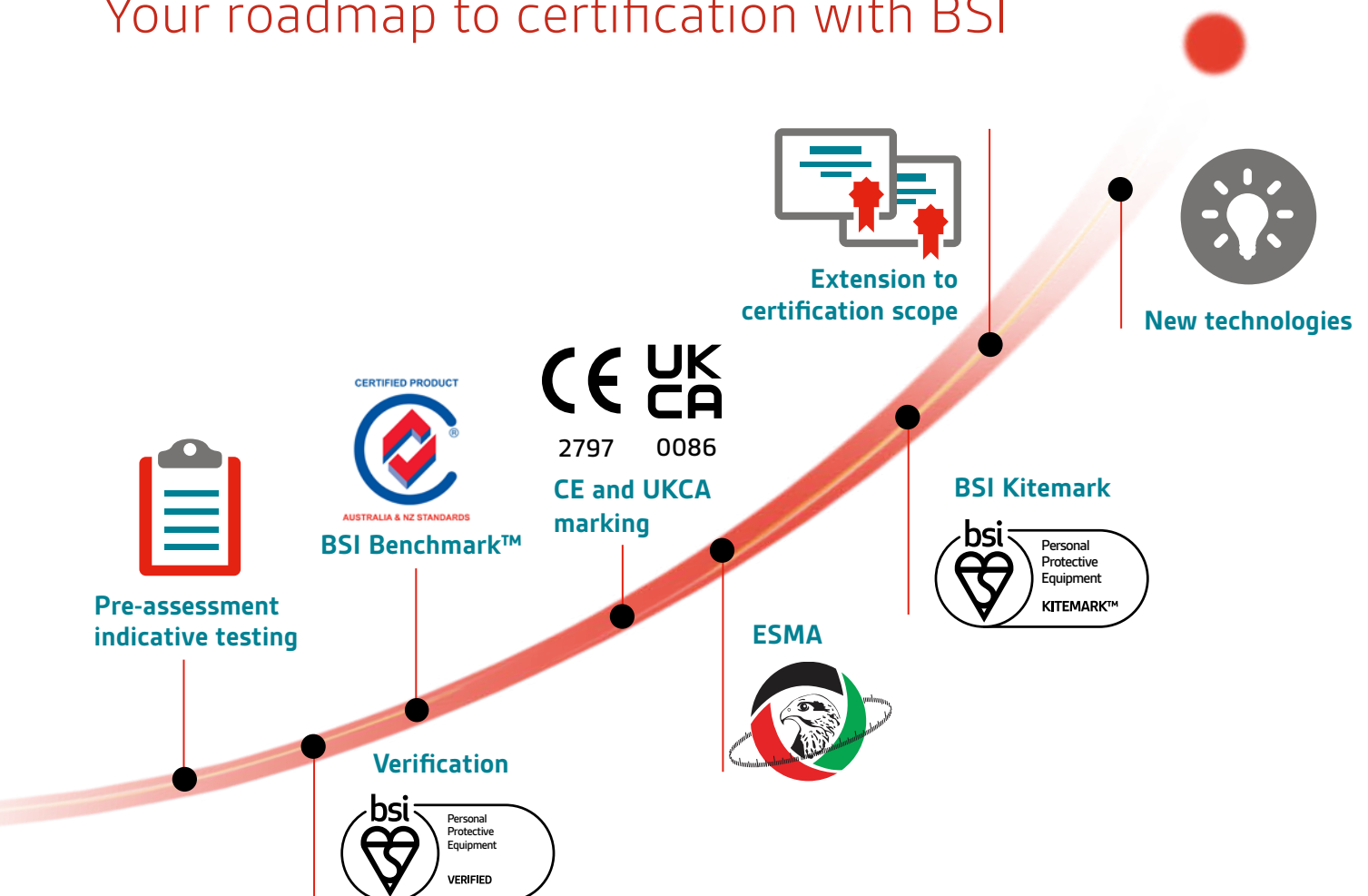

## CE marking

If you want to trade within the European Economic Area (EEA) and your products fall within the scope of the PPE Regulation, they must meet the essential characteristics of the Directive or Regulation and you must make a declaration of conformity. CE marking has to be in place from launch. By CE marking you can offer customers a measure of reassurance about the safety of your products. CE marking on a product indicates that the minimum legal requirements for a product have been

met and allows the product to move freely throughout the European Single Market. As a Notified Body (Number 2797) we have the expertise to help you understand what your responsibilities are, and will provide the third-party evidence you need to be able to affix a CE mark to your products.

### Your commercial advantage:

If the European market is your destination, the CE mark is your route to sales and opportunities.

## UKCA marking

If you want to trade with Great Britain (England, Wales, Scotland) and your products fall within the scope of the PPE Regulation and you must make a declaration of conformity. UKCA has to be in place from launch. By UKCA marking you can offer clients a measure of reassurance about the safety of your products. UKCA marking on a product indicates that the minimum legal requirements for a product have been met and allows the

product to be placed in Great Britain. As an Approved body (Number 0086) we have the expertise to help you understand what your responsibilities are, and will provide the third-party evidence you need to be able to affix a UKCA mark to your products.

If the Great Britain market is your destination, the UKCA mark is your route to sales and opportunities.



## ESMA - enter the UAE international market

The UAE has recently introduced the – 'Regulation for Control on Personal Protective Equipment PPE Regulation No.

(03) year 2016'. BSI is a Notified Body meaning that we can help you with accessing PPE markets in the UAE. We have an extensive scope for certifying which includes; head protection, hand protection, eye and face protection, breathing

apparatus, protective clothing, foot protection, hearing protection, respiratory protection and fall management equipment. We can issue ESMA certifications for Category 1 (simple PPE like sunglasses), Category 2 (intermediate PPE like safety eyewear) and Category 3 (like RPE) products via the appropriate Emirates Conformity Assessment Scheme (ECAS) or the Emirates Quality Mark (EQM) route, details below.

## New technologies



Where new or adapted products are ahead of the curve, a relevant standard may not yet be available. We can still help. We can often use other specifications or technical documents, such as trade association specifications or what are known as publicly available specifications (PAS's). As long as they are robust, developed by consensus and publicly available, we can run a valid certification scheme to them. We are also, where

appropriate, able to combine clauses from specific standards in order to be able to offer third-party certification.

## Medical Device Regulation and PPE crossover

Since the amended Medical Device Directive (MDD) 93/42/EEC came into force in 2010 which allowed MDR products to be dual CE marked both as PPE and MDR we have seen a steady flow of products such as surgical and examination gloves, eye and face protection used in orthopedic procedures, surgical drapes and radiation attenuating products being certified as PPE. This has resulted in us

working closely with the BSI Medical Devices Notified Body team in helping manufacturers gain market access in a joined up approach including joint ISO 13485 and Module D assessments. We can also offer Kitemark for a number of MDR products such as surgical masks and examination gloves which are self declared Class I MDR products.

We offer a comprehensive range of testing and certification for over 90 different standards for BSI Kitemark, CE and UKCA marking, Verification, plus Australia and UAE standards including on-site witness testing and integrated multi-assessments.

Accreditation by UKAS, the United Kingdom Accreditation Service demonstrates the competence, impartiality and performance capability of our services for clients.

For example, with the standards that PPE needs to comply with becoming ever more exacting, our TIL rig already measures at the levels required by the forthcoming ISO standards. Most equestrian head protection is certified to the BSI Kitemark, with the Pony Club of Great Britain specifying it. ## Facial protection

### Hearing protection

Hearing protection requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425.

We also offer voluntary certification with BSI Kitemark and Verification Certificates for certain products. Below



are common examples of products that we test. Similar products can also be tested, please ask us for details.

#### Examples of hearing protection include:

- Ear plugs
- Ear muffs
- Helmet mounted devices
- Level dependant earplugs

### Respiratory Protective Equipment (RPE)

RPE requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425.

All RPE falls into category III PPE and therefore requires EU Type Examination and ongoing surveillance under Module C2 or D of the Regulation. As a Notified Body (EU) and Approved Body (UK) we have the expertise and recognized status to offer this service.

We can offer voluntary certification with BSI Kitemark, and Verification Certificates for certain products. We can also offer certification for breathing apparatus, escape sets and all other types of RPE.

We have increased our capacity in testing RPE, with the opening of our new gas testing lab in 2017. This covers filters testing for face masks used in mining, petrochemical, pharmaceutical, industrial and niche or specialist areas for example. Initially offering Type, A, B, E and K gases we will look to be developing this area to increase its scope.

# Eye protection

Eye protection requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425.

The majority of eye protection products such as safety glasses, goggles and face screens fall within category II. As a Notified Body (EU) and Approved Body (UK) we have the expertise and recognized status to offer this service.

We also offer voluntary certification with BSI Kitemark, and Verification Certificates for certain products. For BSI Kitemark we offer schemes for safety eyewear for products such as safety spectacles, goggles and face screens. We can offer certification for welding shields, sunglasses and swimming goggles. Motorcycle visors do not fall under the PPE Directive or Regulation. We offer BSI Kitemark and Benchmark for UK, global and Australian markets.

# Hand and foot protection

## Gloves

Gloves require mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425. The majority of gloves fall within category II or III PPE and therefore require EU Type Examination and if complex, on-going surveillance too. As a Notified Body (EU) and Approved Body (UK) we have the expertise and recognized status to offer these services. We can provide certification for both PPE and Medical Device products where applicable and have recently opened a test laboratory for protective gloves.

### Examples of hand protection:

- Protective gloves against:
  - chemical permeation
  - mechanical risks
  - heat and fire
  - cold
  - chemicals and micro organisms
- Fire fighting gloves
- Surgical and examination gloves

## Safety footwear

Safety footwear requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425.

We also offer Verification Certificates for certain products.

Dependant on the standard, or optional testing within a standard, safety footwear may require EU Type Examination and if complex, on-going surveillance too. As a Notified Body (EU) and Approved Body (UK), we have the expertise and recognized status to offer these services.

### Examples of safety footwear:

- Protective footwear
- Occupational footwear
- Forestry footwear
- Footwear for motorcyclists

- molten metal

## Impact protection

### Head protection

Head protection requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425.

We also offer voluntary certification with BSI Kitemark, and Verification Certificates for certain products.

The majority of head protection products such as canoeists, equestrian, mountaineering, bump caps, industrial safety,ski helmets and cycle helmets fall within category II PPE. For those which claim electrical or molten metal protection or are fire fighters helmets they require category III.

Mountaineering, skiing, cycling, industrial, fire fighter

## Protective workwear

### Hi-vis jackets

High visibility clothing requires mandatory CE and UKCA certification under the PPE Regulation (EU) 2016/425. High visibility clothing depending on the standard used and colour of the garments, can be either category I or category II PPE. We also offer Verification Certificates for certain products.

### Fall arrest

Fall arrest equipment falls under mandatory CE certification under the PPE Regulation (EU) 2016/425. All fall arrest equipment falls into category III PPE and therefore requires EU type Examination and on-going surveillance. As a Notified Body we have the expertise and recognized status to offer these services.
