In this case study we will review the results of an observational assessment on how electric sit/stand work stations are used in a 500 person call center.

Over multiple days, people were observed on how they were using their sit/stand work stations. The main focus was around proper posture and correct set up of their work station. In this case study we will discuss whether or not the objective of improving posture and reducing ergonomic risk was achieved through the use of sit/stand workstations.

For any organization using or thinking about investing in this technology this will be an invaluable insight into the sit/stand phenomenon.
