



TickIT-certified IT organizations, the foundation level provides a straightforward opportunity to transfer to the TickIT*plus* scheme. And the higher levels allow you to move beyond conformance to performance.

One of the great strengths of the TickIT*plus* scheme is the quality of the auditors that carry out the assessments. All of the auditors have demonstrated both strong industry knowledge as well as the required skills to audit within the IT sector. We match auditors to organizations based on their specific skills, which fulfil the eight TickIT*plus* scope profiles. These profiles are: legal and compliance, service management, systems and software development, project and programme management, corporate strategy planning and management, information management and security, and IT systems engineering and infrastructure.

TickIT*plus* provides a robust software and IT quality benchmark that meets business user needs. It allows for the optional inclusion of other key IT standards including ISO/IEC 27001 for information security and ISO/IEC 20000-1 for IT service management. While all very different, these standards have many common features, and can be intergrated using the TickIT*plus* scheme.
