#### 3. Summary of Assessment

BSI has conducted RSPO Supply Chain Certification assessment of PT Inti Indosawit Subur – Ukui 1 Kernel Crushing Plant. The Ukui 1 Kernel Crushing Plant is located within Ukui 1 Palm Oil Mill.

It is noted that the kernel crushing plant sourced the raw material (palm kernel) directly and only from RSPOcertified Ukui 1 Palm Oil Mill. Ukui 1 Palm Oil Mill has been certified against RSPO P&C 2013 and RSPO Supply Chain Certification Standard for CPO Mills Module D: Identity Preserved.

BSI conducted the assessment process against the requirement of RSPO Supply Chain Certification Standard: 21 November 2014. The palm kernel from Ukui 1 Palm Oil Mill stored on dedicated kernel silo before processed into palm kernel oil and palm kernel expeller. All aspects of the standard have been implemented and recorded. The certification unit demonstrated traceability and record keeping, as well as keeping the products 100% segregated. BSI recommends the certification of PT Inti Indosawit Subur – Ukui 1 Kernel Crushing Plant as a producer of RSPO certified sustainable palm kernel oil and palm kernel expeller.
