It delivers multiple benefits to the aerospace industry including:

- Win business aerospace OEMs use the standards and registration to the standards as contractual requirements for their supplier
- Continual improvement because the safety and performance aspects of aerospace products are critical to stakeholders

With greater involvement in the management system by the leadership team, the new standard ensures top management is held to account for the system's effectiveness and that the whole organization understands their role and contribution to quality.

Introduction of Risk & Opportunity Management

The introduction of risk and opportunity management into your management system now reinforces its use as a governance tool. This will ensure that it will be quicker and easier to implement multiple management system standards, saving both time and money. This holistic approach provides even greater benefits by reducing duplication, increasing efficiency and providing a complete view of the whole organization.

An Integrated Approach

ISO has introduced a common structure and core text for all its management system standards. As the new AS/EN 9100 is largely based on ISO 9001:2015 it follows this same structure. 
