Production Part Approval Process (PPAP) is used in the automotive supply chain for establishing confidence in component suppliers and their production processes. Often required by OEM's, it is a process to show your customer that you can consistently make their parts on an on-going basis and minimize the risk of failure. It is one of the Core Tools which form the building blocks of an effective quality management system such as IATF 16949.

If you are involved in the submission of parts to customer(s) for part approval, involved in the Advanced Product Quality Planning (APQP) process, or if you are involved in the implementation of IATF 16949, then this one-day course could be beneficial for you.

In this course you will learn how to identify PPAP submission requirements including those which are customer-specific. You will also gain the knowledge to determine documented information to be retained and retention times.

Delegates should already have a good understanding of ISO 9001:2015 and IATF 16949:2016, and ideally will have already completed our Core Tools training course which this course builds on.
