The ISO 14001:2015 is now published and ISO 9001:2015 is expected to be published on 22 September 2015. We are proud to announce that BSI is the first to receive official global accreditation status from the ANSI-ASQ National Accreditation Board (ANAB) for the new Quality Management Systems Standard, ISO 9001:2015, once it is published.

The revisions are considered to be a big change which the changes have altered the structure and format for the new standards. With an increased focus on the importance of 'Leadership', the new standards will be adopting a 'High Level Structure' and others new requirements to facilitate a better alignment between different quality systems and improve the effectiveness and risk management of the management systems.

As the final standard is published, all organizations will now have three years to transition to the new standard.
