These offences resulted in around 51.63 million Euros' worth of costs – a figure that is showing an upwards trend. "We are helping to combat the very real threat that cybercrime poses by increasing the resilience of our customers, helping them to protect their critical information and expertise and providing them with support as they expand their IT infrastructure", states Thomas Ohnacker, Professional Services Manager CE & CIS at BSI Group Deutschland.

Vulnerability analyses provide companies with a snapshot of the existing level of risk from exploitable vulnerabilities. The risk potential of companies is greatly reduced as a result of eliminating the identified vulnerabilities.
- Support in the areas of eDiscovery and digital forensics, as well as for legal disputes. In these areas in particular, BSI offers tailor-made solutions that are designed to meet the exact requirements of the specific companies. Here, BSI can draw on a Europe-wide network and knowledge from all over Europe to achieve reproducible results that are in line with legal regulations.

- Cyber Security training sessions to prepare employees in the company for the new EU General Data Protection Regulation (EU GDPR), which comes into force in May 2018.

- Consulting, auditing and certification within the framework of the Payment Card Industry Data Security Standard (PCI DSS), which is used to protect credit card payment systems. This security standard was developed by an expert committee from the major payment card brands and covers the basic aspects of information security with regards to the factors of humans, processes and technologies that are involved in credit card payment systems.
- **Introduction, auditing, training and certification**: ISO 27001, ISO 22301 (BCM), BS 10012 (data protection), CSA STAR (cloud computing), ISO 27018 (data protection for cloud services), PCI DSS.
