

Software Licence Agreement – Android Security Testing Framework

IMPORTANT - Please read carefully before using the software defined in this agreement. The software product, called Android Security Testing Framework (ASTF), which includes computer software, its associated documentation, on-line explanatory information and any updates or supplements to the original software product, (together, the "**Software**") is offered by BSI Cybersecurity and Information Resilience (Ireland) Ltd, at the address of Corrig Court, Corrig Road, Sandyford Industrial Estate, Co. Dublin, Ireland (the "**Developer**") for license subject to your (the "**Licensee**") acceptance of the terms and conditions of this Software Licensee Agreement (the "**Agreement**") which are legally binding between the Developer and the Licensee. By downloading the Software you accept the terms and conditions of this Agreement. If you do not accept these terms and conditions you must return or delete the Software.

1. License. In consideration of the Licensee's agreement to the restrictions of use of the Software contained in this Agreement, the Developer hereby grants to Licensee a personal, non-exclusive, non-transferable, limited (time) license to use the Software in its object code form only upon the specified number of devices in the Documentation. The Software must be used exclusively for Licensee's own internal information processing services and on a device or network that it either owns or has an appropriate license to use. Other than expressly set out in this Agreement, the downloading of the Software does not grant Licensee any rights or title to the intellectual property in the Software, all of which are reserved by the Developer.

2. Restrictions. Licensee shall not modify, copy, duplicate, reverse engineer, de-compile, reproduce, rent, loan, license or sublicense the Software, or transfer or convey the Software or any right in the Software or permit the Software or any part of it to be combined with, or become incorporated in, any other programs. To use the Software for any purpose or manner not provided in Clause 1, or to do anything prohibited in this Clause 2 is a material breach of this Agreement and may violate the laws of copyright.

3. Limited Warranty. For 30 days from the date Licensee downloads the Software, Developer warrants that the Software shall perform substantially in accordance with the Documentation provided always that: I) the Software has been installed and operated in accordance with the Documentation; ii) Licensee promptly notifies Developer of any breach or alleged breach of this warranty; and iii) Licensee has correctly installed any updates or corrections issued by Developer. Licensee's sole and exclusive remedy for Software's non-compliance with this warranty shall be that Developer shall, at its option, permit Licensee to download a replacement version available at the time of breach of warranty, or terminate this Agreement.

4. Property Rights. Software is licensed and not sold. Developer owns all title and intellectual property rights in and to the Software and any copies thereof. The source code of the Software is a valuable trade secret of, and is confidential to, the Developer. Developer has the right to use at any time, at its discretion, and with any third party, any suggestions of the Licensee about the Software and may use such for current or future products without approval of, or the need for compensation to, Licensee...

5. Disclaimers. Software is designed to disclose and to exploit security vulnerabilities and its operation may affect the performance of targeted systems and devices or create problems therein. Software is not warranted to: i) work uninterrupted or error-free; ii) detect all security threats, vulnerabilities, intrusions or other harmful or undesirable programs; iii) to meet Licensee's specific requirements; iv) to render Licensee's systems and devices invulnerable to security breaches; or v) work in fault intolerant or high risk environments. Licensee hereby accepts the risks associated with use of the Software and hereby waives any rights or causes of action arising from use of the Software as described in this clause 5.

6. No Other Warranties, Terms, Conditions or Representations. THE WARRANTY, TERMS AND CONDITIONS EXPRESSLY STATED IN THIS AGREEMENT ARE IN LIEU OF ALL OTHER WARRANTIES, TERMS OR CONDITIONS, EXPRESS OR IMPLIED WHETHER BY STATUTE, COMMON LAW, CUSTOM, COURSE OF DEALINGS OR OTHERWISE, INCLUDING, BUT NOT LIMITED TO IMPLIED WARRANTIES, TERMS OR CONDITIONS RELATING TO MERCHANTABILITY, TITLE OR FITNESS FOR A PARTICULAR PURPOSE ALL OF WHICH ARE EXCLUDED TO THE MAXIMUM EXTENT PERMITTED BY LAW. LICENSEE EXPRESSLY ACKNOWLEDGES THAT IN ENTERING INTO THIS AGREEMENT IT HAS NOT RELIED ON ANY REPRESENTATIONS, WHETHER ORAL OR OTHERWISE, NOT EXPRESSLY STATED HEREIN.

7. Limitations of Liability. A) Developer does not exclude or limit its liability for i) death or personal injury caused by its negligence, or ii) fraudulent misrepresentation. B) Despite anything else in this Agreement but subject always to clause 7A above, Developer shall not be liable to Licensee for loss PRIVATE & CONFIDENTIAL BSI Cybersecurity and Information Resilience (Ireland) Ltd 20 March 2017 Page 3 of 4 (whether direct or indirect) of profits, or anticipated savings (whether of personnel or otherwise), for loss of programs or for any indirect, incidental or consequential loss or damage whatsoever even if Developer shall have been advised of the possibility of it and whether arising in tort (including negligence), breach of contract or howsoever. C) Subject always to clauses 7A and 7B, where Developer is liable to Licensee, whether arising through breach of contract, negligence, tort or otherwise, Developer's aggregate liability shall not exceed the sum of €500.

8. Term and Termination. Upon expiry of the Term this Agreement shall automatically terminate. In the event of a material breach of this Agreement, Developer may terminate this Agreement immediately by notice in writing. Licensee may terminate this Agreement by permanently deleting the Software. Upon termination, for whatever reason: i) all rights granted to Licensee under this Agreement shall cease, ii) Licensee must cease all activities authorized by this Agreement; iii) Licensee shall immediately delete all copies of the Software.

9. Export. Any export by the Licensee of the Software shall be done in accordance with this Agreement. Licensee is exclusively responsible for complying with all applicable export laws, including United States and European Union trade sanctions and export regulations, regardless of the country in which Licensee is located or which Licensee is a citizen.

10. Notices. Any notice required by this Agreement or given in connection with it, shall be in writing and shall be sent to the registered address of the appropriate party by personal delivery, by certified mail (postage prepaid), e-mail, recognized overnight delivery services or facsimile provided that a confirmation of transmission is produced by the sending machine and a copy of such facsimile is sent by other means specified in this clause 10.

11. Reservation of Rights. Developer reserves any rights not expressly granted by this Agreement. Should either party waive any of its rights under this Agreement, such waiver shall not be considered to be permanent or to set a precedent and either party may at any time insist upon its full rights.

12. No Assignment. Neither this Agreement nor any interest in this it may be assigned by Licensee.

13. Governing Law. This Agreement shall be governed by and interpreted in accordance with the laws of Ireland and the parties submit to the exclusive jurisdiction of the Irish Courts. PRIVATE & CONFIDENTIAL BSI Cybersecurity and Information Resilience (Ireland) Ltd 20 March 2017 Page 4 of 4



14. Entire Agreement. This Agreement terminates and supersedes all prior understandings or agreements on the subject matter hereof. This Agreement may be modified only by a further written amendment duly executed by the authorized representatives of both parties. Any terms or conditions on Licensee purchase orders or other purchase documentation that conflict with this Agreement are null and void.

15. Severability. If any term, condition or warranty of this Agreement, or part thereof, is held by a court of competent jurisdiction to be invalid or unenforceable then this Agreement, including all of the remaining terms, conditions and warranties will remain in full force and effect as if such invalid or unenforceable term, warranty or condition or part of thereof had never been included.

16. Headings and Interpretation. Headings used in this Agreement are provided for convenience only and shall not be used to construe meaning or intent.
