

ISO FDIS 9001:2015 and ISO DIS 9001:2014 **Comparison Guide** 



## Introduction

ISO FDIS 9001;2015 - Quality Management Systems- requirements was published on 09 July 2015 and supersedes ISO DIS 9001:2014. This document provides an overview to the differences between the two standards and is intended for users to enable an understanding of these differences.

It should also be noted that there are changes in Annex A & B of ISO FDIS 9001:2015 when comparing against Annex A & B of ISO DIS 9001:2014, of particular note are the following:

- 1. Annex A.3 now concentrates specifically on understanding the needs and expectations of interested parties (Clause 4.2) rather than the overall subject of 'context of the organization' (Clause 4)
- 2. Detail regarding the quality management principles that was previously in Annex B has now been moved to Section 2 of ISO 9000: 2015 whilst an overview is given in the introduction of ISO FDIS 9001 (Section 0.2).
