A snapshot of some of our projects to date

Putting quality at the heart of a complex business

The European Patent Office (EPO) decided to partner with BSI Consultancy to guide them along the path to successful ISO 9001 certification. The process involved establishing a solid structure of project management and helping the management team to develop an effective internal communication strategy to clarify the benefits of using ISO 9001 throughout the business. Team members were then trained to use the new communication strategy, ensuring it reached all levels of the organization.

The project kicked off in January 2014 and nine months later EPO successfully passed their 14-day certification audit without a single non-conformity being raised. The ISO 9001 initiative is now also being rolled out to other parts of the business.

Driving global organizations towards resilience

The board of a global thought-leading organization wanted to focus on organizational resilience in order to overcome their business challenges, meet their performance objectives and deliver the financial results expected by their stakeholders.

A BSI consultant worked closely with the executive directors to identify their key drivers and strategic goals, and to review the enterprise-wide risks which were most likely to adversely impact the successful achievement of their business plan. Consequently three key areas were prioritised by the board for improvement and risk mitigation. These were Crisis Management, Business Continuity and Information Security, all of which could result in reputational and financial damage to the organization.

The consultancy solution resulted in the directors being coached on decision-making in a crisis, through live realistic scenarios, providing them with confidence and hands-on practice, as well as the knowledge that they could function effectively as a team if a future crisis occurred.

To manage the risks associated with protecting customer and company information, an Information Security policy was designed and implemented globally, supported by awareness training and simple procedures and controls, enabling compliance with ISO27001 (Information Security Management). Similarly, compliance with ISO22301 for Business Continuity management was also achieved under guidance from the BSI consultant, minimising the risks and impact to the global organization in the event of a business disruption.
