**Invitation to comment on RSPO Certification Assessment of PT Agro Wana Lestari, Bukit Santuai Palm Oil Mill, Central Kalimantan Province, Indonesia.**

PT Agro Wana Lestari, a subsidiary of Goodhope Asia Holdings Ltd (RSPO Membership No: 1-0175-14-000-00), has appointed BSI to conduct RSPO Certification of its palm oil mill and supply base. The certification will be conducted in 1 Palm Oil Mill and 4 Oil Palm Plantations which are managed by the company. The company is located in Central Kalimantan Province, Indonesia.

BSI plans to conduct certification of PT Agro Wana Lestari on 25 – 29 May 2015. The Assessment will be conducted based on the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2013 and RSPO SCCS November 2014 relevant to CPO Mills. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
