Invitation to comment on RSPO Re-Certification Assessment of Sime Darby Plantation Sdn Bhd, Sungai Dingin Palm Oil Mill – Padang Serai, Kedah, Malaysia.

Sime Darby Plantation Sdn Bhd (RSPO Membership No: 1-0008-04-000-00) has appointed BSI to conduct RSPO Re-certification assessment of its Sungai Dingin Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 7 Oil Palm Plantations which are managed by the company. The certification unit is located at Padang Serai, Kedah, Malaysia.

BSI plans to conduct re-certification assessment of Sungai Dingin Palm Oil Mill on 9th to 12th June 2015. The assessment will be conducted based on the Malaysia National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills: 21 November 2014. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
