Invitation to comment on RSPO Initial Certification Assessment of PT. PP London Sumatra Indonesia Tbk — Tirta Agung Palm Oil Mill and Supply Base in Musi Banyuasin Regency, Sumatera Selatan Province - Indonesia

PT. PP London Sumatra Indonesia Tbk – Tirta Agung POM (RSPO Membership No: 1-0015-04-000-00), has appointed BSI Services Malaysia Sdn Bhd to conduct Initial Certification Assessment of its palm oil mill and supply base. The certification scope will consist of one (1) palm oil mill and three (3) company - owned estates. The company is located in Musi Banyuasin Regency, Sumatera Selatan Province, Indonesia.

BSI Services Malaysia Sdn Bhd plans to conduct initial certification assessment of PT. PP London Sumatra Indonesia Tbk – Tirta Agung Palm Oil Mill and its supply bases on 28 – 30 November 2017. The assessment will be conducted based on the RSPO Indonesia National Interpretation 2016 and RSPO Supply Chain Certification Standard: November 2014 for Supply Chain Requirement relevant to CPO Mills. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
