#### **BIM Objects Standard**

The assessment standard is BS 8541 - Library objects for architecture, engineering and construction:

- Part 1 Identification and classification
- Part 3 Shape and measurement
- Part 4 Attributes for specification and assessment

The requirements of each part provide best practices for producing BIM Objects you can trust; compliance to the

standard is independently assessed by BSI's technical experts.

We've also developed an additional set of requirements for the Kitemark that build on these standards and are based on industry feedback, to help ensure your BIM content is of the highest quality.

# The BIM Objects Kitemark certification journey

In order to demonstrate your capability to work in compliance with BS 8541 and achieve the BSI Kitemark for BIM Objects here is what you can expect in six simple steps.

#### Step 1 Download a copy of BS 8541

Download BS 8541 Parts 1, 3 and 4 from the BSI Shop, here: **bsigroup.com/BIM-standards-uk**. This is the standard you'll be assessed against and it contains all the requirements you'll need to meet to achieve the BSI Kitemark for BIM Objects.

#### Step 2 Complete your application form

Contact our BIM team to confirm your scope of assessment and start the assessment process. We'll assign you a Certification Manager, who will be your point of contact through the process – and beyond. They'll have an excellent understanding of your business area and will support you as you move forward to assessment and certification. #### Step 3 BIM training

#### Step 4 GAP Assessment to make sure you're on track

We can carry out an optional gap assessment, of your documented system against the requirements of the standard and identify any omissions or weaknesses that need resolving before formal assessment. We also offer this a standalone option, if you are unsure about committing to certification at this stage.

#### Step 5 Formal assessment to achieve your BIM Kitemark

We'll conduct an assessment, the length and scope of which will be tailored to your specific requirements. Our on-site assessment includes reviewing a sample of your physical objects against your BIM Objects and product data. We'll also require your authoring consultant/contractor to demonstrate your BIM objects during assessment.

#### Step 6 Certification and beyond

Once the assessment has been successfully completed, we'll issue your BSI Kitemark certificate which can help grow your business. We will then be conducting surveilance visits on an annual basis, to review any changes to your BIM content and processes and to ensure you continue to meet the latest standards.
