## Supply Chain Verification: The Higg Index Facilities Environmental Module (FEM)



The Sustainable Apparel Coalition (SAC) is working to reduce the environmental and social impacts of apparel and footwear products around the world through their self-assessment tool, The Higg Index, and implementing the New Verification Pilot for the Higg Facilities Environmental Module (FEM).

This Verification Pilot was developed to help organizations create a more sustainable and responsible supply chain. The goal of the pilot program is to build trust in the Higg data so that it can be more effectively used in decision-making and consumer labeling while eliminating redundancy in assessments. Higg Verifications will furthermore enables manufacturers to spend more resources on capacity building, and change the mind-set from compliance to performance improvement.

The Sustainable Apparel Coalition aims to help their members better identify gaps and potential risks throughout their supply chain, to support member efforts in creating a sustainable supply chain.

The SAC Higg Verification Pilot began July 2015 and will remain active until December 2015. During this time a minimum of 200 facility environmental modules verifications will be conducted on a first come first serve basis – all facility types are welcome.
