BSI Commonwealth Standards Network (CSN)

The Commonwealth Standards Network (CSN) provides technical assistance, training, and written/online resources to increase technical and institutional capacity of Commonwealth members to use and participate in the development of international standards.

International standards play an important role in promoting productivity and efficiency, reducing costs, removing barriers to trade, and driving economic growth. As such, the CSN is especially relevant to National Standards Bodies from Commonwealth nations that are looking to boost their international trade capabilities.

International Policy

BSI is a founding member of ISO, IEC, CEN and CENELEC and is a permanent member of their governing bodies. The International Policy team coordinates the development of the BSI view on all governance issues, briefs senior BSI representatives, and themselves represent BSI in many of the governance and policy making bodies of the European and International organisations. Trade and Regulatory Policy

This will be an opportunity to talk to the BSI standards team directly about regulatory changes to the UK post 2020 and how they impact standards. This includes the new UKCA mark, the continuation of the CE marking in Northern Ireland and the introduction of the UK internal market. The team will also be able to talk through 'designated standards' which replace 'harmonised standards' in the legal framework for Great Britain.

Beyond the regulatory area, we have been working with government to stress the important role standards play in reducing barriers to trade and enabling UK access to global markets. We would welcome any questions you may have on BSI's trade activity.
