Understanding the rules for civil defence contracts in the UAE

Information for exporters



Introduction



In the United Arab Emirates (UAE), civil defence departments are responsible for public safety. Federal Law No. 23, introduced in the UAE in 2006, describes their role as being responsible for: "the protection of lives, properties and sources of national wealth during peace and war times and crisis and emergency situations".

The word 'peace' here is key: the responsibility of UAE Civil Defence is to protect civilians at all times and in their daily lives. It follows that there are strict UAE Civil Defence rules to prevent products that could endanger life entering the UAE market and supply chain. This document provides an overview of these rules and we show how BSI experts can work with you throughout the conformity process.

About the UAE Civil Defence rules

What do the rules cover?

The rules are implemented under the UAE Fire and Life Safety Code of Practice and include specifications for the design of both buildings and products. The Code was updated in 2017 after a series of fires in Dubai. Among the product categories covered are:

- Fire suppression
- Fire detection
- Emergency lighting
- Gas products

BSI has been accredited for some time and have recently extended our scope to include gas.

Geographically, the scope of the rules is broader than the seven Emirates states. Where the UAE leads in terms of assessing product quality and performance, neighbouring states — such as Kuwait, Oman, Qatar and Saudi Arabia — often follow. A certificate of conformity with UAE Civil Defence rules, then, strengthens the position of exporters to the Middle East in general.

About the conformity process

The route to certification involves four basic steps:

- 1 Application to an accredited testing and certification body such as BSI
- 2 Factory inspection
- 3 Type testing
- 4 Final inspection followed by certification, once all necessary requirements have been met

As with all type five certification schemes, conformity is an ongoing process, with steps two and three regularly repeated to ensure standards are being maintained. If you make any changes to your product design or to your production processes you will need to inform your certification body as this will require further tests to be carried out.

UAE Civil Defence and BSI Kitemark[™]certification

We work closely with the UAE Civil Defence and they perform regular audits of our gas product testing facilities in the UK to ensure we meet their requirements.

BSI Kitemark certification is now widely specified for civil defence contracts throughout the Middle East as certification is of a similar level to the Emirates Quality Mark (EQM).

We offer BSI Kitemark certification for:

- fire detection and suppression products
- emergency lighting, emergency control gear and lighting systems
- gas products such as gas hoses and connectors.

Certificates of Conformity (C of C's) are issued by BSI in conjunction with Kitemark certification.

We are able to accept test results from other accredited laboratories. In these cases our experts would review the test report and the rules of the Dubai Civil Defence approved Certification Bodies list would apply.
