

# Entrance Doorset Dual Certification – (Fire Characteristics and Enhanced Security)

## BSI provides Kitemark scheme in response to Government guidance

Following the outcomes of the Dame Judith Hackitt's Independent Review of the Building Regulations and Fire Safety Emerge, BSI is now able to certify doorsets which require both fire and enhanced security characteristics.

Government advice published in May 2018 for building owners regarding assurance of flat entrance doorsets and again in August 2018 on how composite front doors should be tested and classified, was followed by Secured by Design (SBD) implementing a requirement to their specification, that would ensure entrance doorsets that require both fire and enhanced security shall be tested to the same specification and certified by a single body.

BSI Kitemark certification for enhanced security to PAS 24 has been leading the way as the ultimate mark of trust in this field for over 25 years and we recognize the importance of supporting manufacturers to build trust in their products. This additional Kitemark for Entrance Doorset Dual Certification (Fire Characteristics and Enhanced Security) will help clients demonstrate their ongoing commitment to building a safer world.

### Compliance

In accordance with SBD specification and guidance for flat entrance doorsets, BSI dual certification enables a manufacturer to demonstrate compliance with Ministry of Housing, Communities and Local Government Advice Note 16 (point 17) which requires products to be certified to a single specification for enhanced security and fire resistance.

Additional assurance can be provided for The Construction Products Regulation ensuring fire doorsets can be CE and/or UKCA marked.

### Confidence

Provide reassurance to your stakeholders, including regulators, specifiers and building owners that your products meet local authority frameworks and PQQ's through standards and best practice – enabling access to more contracts.

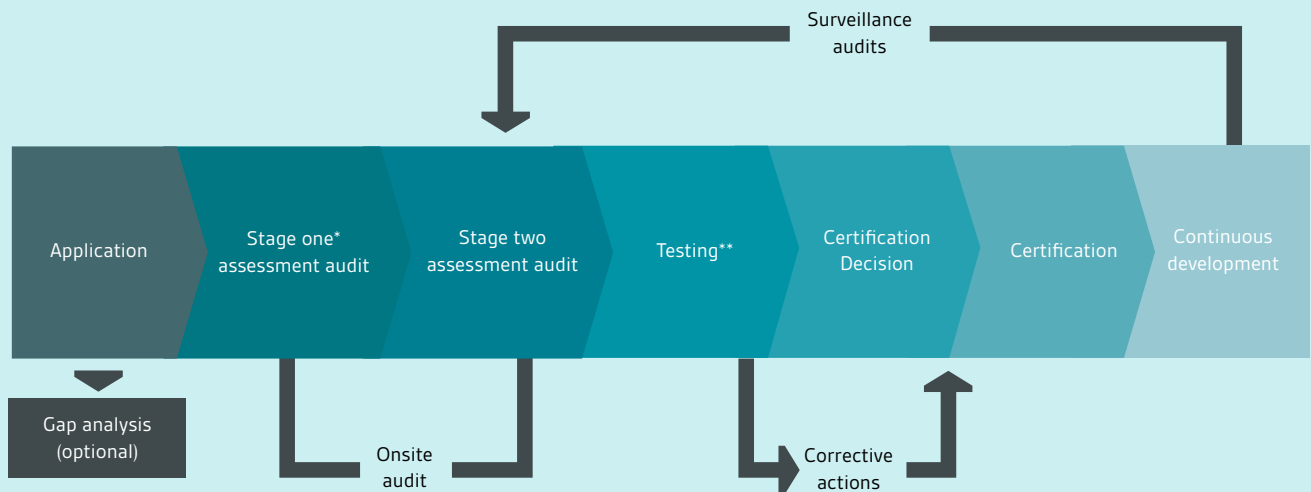
