Phase One Training

Day One - Requirements Training Course

Participants learn the key components of the health and safety aspects that align with the ISO 45001 standard and what it requires of them. Your project team will gain an in-depth understanding of the terms, definitions, and main requirements defined as best practice in standard.

Day Two - Continued Training Course and Connect Mobile App

In the morning, participants gain an understanding of the context of the organization and learn how to identify hazards, risks and opportunities.

In the afternoon, training on the Connect mobile app is provided to convey the features and functionality around the keys areas of your business.



Phase Two

Using the Connect Mobile App

The client project team uses the Connect mobile app to identify and record the level of the organization's commitment, communication and awareness as well as identify risks, opportunities and best practices. All data is recorded using the Connect mobile app and the data is fed into the Incident tool. All of this information contributes to the Health and Safety Baseline Report.

Return to work

Employees will be encouraged to capture incidents about new protocol, hygiene, social distancing, and other incidents pertaining to the "next normal".



Phase Three

Gap Assessment

Day One - Assessment Questionnaire

The BSI auditor visits on-site completes the assessment questionnaire. This data contributes to the Health and Safety Baseline Report, along with data collected during Phase Two.

Day Two - BSI Gap Assessment

The BSI auditor presents the Health and Safety Baseline Report. Based on the information gathered, the report will highlight the weaknesses, strengths, and gaps in your system and serve as the gateway to your ISO 45001 Health and Safety journey. And allow you to benchmark the new precautions in place for returning to work in the face of the pandemic.
