FEATURES AND BENEFITS

The BES 6001 framework standard for the Responsible Sourcing of Construction Products has been published in response to pressure for the construction products industry to take a more responsible and sustainable approach to the sourcing of materials that go into making construction products. The standard describes the organisational governance, supply chain management and environmental and social aspects that must be addressed in order to ensure the responsible sourcing of construction products.
