Introduction

All CE marking Directives and Regulations require the manufacturer of product or company that use their own brand on the product to create a technical file. Some of these Directives or Regulations does not require input of a National body to affix CE mark and is based on self declaration such as Low Voltage Directive (LVD) or Restriction of Hazardous Substances (RoHS). Due Diligence Verification scheme from BSI has been



developed to provide reassurance to companies offering own, or third-party products to the market...

The BSI scheme provides companies with piece of mind that the product offered meet the minimum legal requirements verified by UKAS-accredited and world-renowned certification body – BSI.

How it works

Reviews, audits and product testing tailored to your needs...

The service is split into three confidence levels, reflecting the different level of confidence between applicant and its supply chain. In each case, you'll receive a BSI due diligence report providing details of the review we've carried out and the result.

Confidence Level 1

Suitable when risk is relatively low, this involves a desktop review of relevant declaration of confirmities, test report(s) provided by a company or their supplier.

We'll ask you to send us documentation on the product(s) in question and we'll tell you if that documentation demonstrates compliance with the relevant international/European quality standards and Directives. We'll also evaluate the accreditation status of any issuing bodies.

At confidence level 1 we won't physically test the product(s), we'll disassemble samples and compare components against test reports to check for discrepancies between build and bill of materials. This will give you the confidence OEMs are meeting their contractual obligations, that the product you were sold it the product you received, and that any components you use or equipment you brand with your own name meet quality and safety standards.

Confidence Level 2

In addition to documentation review described in Confidence Level 1, BSI will conduct electrical safety testing against the relevant product standard on a stock product at one of our Centres of Excellence.

We'll check, for example, that samples meet electrical safety criteria and carry out spot checks on components for RoHS compliance.

Confidence Level 3

Confidence level 3 includes all steps covered in level 1 and 2, but in addition it includes factory production surveillance.

We'll compare models being manufactured against models and technical data used for certification, and review in-line and final inspection quality control tests and procedures.



Each level comes with a Due Diligence Verification certificate from BSI. Whichever level you choose, you can demonstrate to customers you take product quality and safety seriously and have been reviewed by an independent third party.
