Security should be an essential part of the design process for all consumer IoT products. We

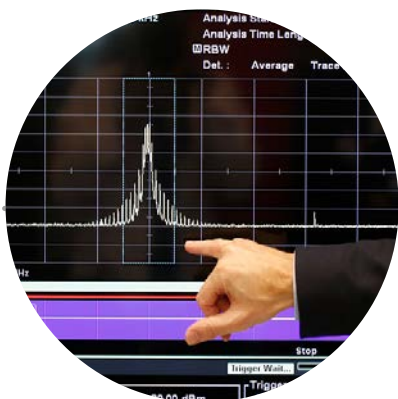
