The standard has been updated to explicitly include cybersecurity and privacy protection, reflecting their integral role in effective modern management of information security.

AdvanceTrack's successful transition to ISO/IEC 27001:2022 demonstrates the security of its service offering to customers and prospects, with BSI certification to the updated standard helping differentiate the company from its competitors.

Sheth was particularly impressed by BSI's willingness to respond rapidly throughout, providing clarity quickly and efficiently when it came to interpreting new clauses – for example, around protecting the privacy of client data – so that the company could implement the necessary cyber security enhancements.
