Frequently Asked Questions

1. What is RTTP?

Reindustrialisation and Technology Training Programme (RTTP) is a funding programme under the launch of the Technology Talent Scheme of the Government of the Hong Kong Special Administrative Region. It aims at subsidising local companies on a 2:1 matching basis to train their staff in advanced technologies, especially those related to "Industry 4.0".

2. What type of company is eligible to apply for the training grant?

A company is eligible to apply for training grant for its employee(s) if:

- it is registered in Hong Kong under the Business Registration Ordinance (Cap. 310);
- 2. it must be a non-government and non-subvented organisation; and
- 3. the employee nominated receiving training is a Hong Kong permanent resident with the necessary background / experience relevant to the advanced technology of the training course.

3. What is the funding ceiling?

Each company is subject to a funding ceiling of HK\$500,000 in each financial year.

4. How to apply for training grant?

Companies interested in applying for training grant for their employee(s) to attend registered public courses may complete the Form 2A and submit to the Secretariat (in person, by post, by fax or by email) together with supporting documents (i.e. copy of the Business Registration Certificate and copy of HKID for each employee applying the training grant) <u>at least</u> <u>two weeks</u> before course commencement. A list of registered public courses is available for reference. For tailor-made courses, companies should apply for course approval and training grants in one go (Form 2B).

5. How will the applications be processed?

The public courses submitted by course providers or the tailor-made courses submitted by companies will be vetted by the Course Vetting Panel under the Innovation and Technology Training Board of the Vocational Training Council. Advice from technical experts will be consulted by the Course Vetting Panel as appropriate.

The training grant applications submitted by companies for registering public courses under the RTTP will be vetted by the Secretariat.

6. How to apply for reimbursement of the training grant?

The training grant is payable upon the requirement of completion of the training and payment of course fees as confirmed by the course provider. Companies are required to submit the claim form together with other supporting documents (e.g. confirmation of training completion and payment, receipt of subsistence allowance, original of the return passage boarding pass/ticket and certified true copy of the receipt (if applicable) etc.) to the Secretariat for reimbursement <u>within two months after</u> <u>course completion</u>.
