What is RTTP?

Reindustrialisation and Technology Training Programme (RTTP) is a funding scheme under the Innovation and Technology Fund that subsidises local companies 2/3 of the training cost to train their staff in advanced technologies, especially those related to "Industry 4.0". Each company is subject to a funding ceiling of HK\$500,000 in each financial year at the course commencement date. Companies should contribute no less than one-third of the actual training cost.
