

Building Information Modelling (BIM) ISO 19650 Part 2: Project Delivery Training course



Essential information about the course

This course will help you understand the information management processes that are needed for a design and construction project to be delivered using BIM according to ISO 19650 Part 2: Project Delivery Training. The course follows on from the BIM Fundamentals course, where information management concepts and principles are introduced.

The course explains ISO 19650-2 as a standard and the terminology it uses, as many terms have been changed from original UK terms to make the standard internationally acceptable. It covers how to set information requirements and select suppliers, and how suppliers of information (designers, contractors, manufacturers) respond with their information plans. It also explores how information requirements are cascaded down through a delivery team.

You'll look at Specific Common Data Environment processes for project information and information management responsibilities, as well as the skills and capabilities required from both clients and their suppliers.
