






The BSI Kitemark for Functional Safety is the benchmark in best practice for validating Safety Integrity Levels (SIL) of electrical and electronic safeguarding systems. It assures the integrity of SIL throughout the full lifetime of these products.



Products include:

- Valves and emergency shut-off systems
- Detection sensors for fire, smoke, heat and security
- Alarm systems for fire and security
- Emergency lighting
- Battery-powered emergency back-up systems
- Automatic Burner Control Systems

The importance of reliable functional safety

Functional safety is critical to ensuring that these safeguards work exactly as they should at the moment they're needed – even if they may be dormant for extended periods. The purpose is threefold:

- **To prevent harm**, injury or death to people and livestock
- **To prevent environmental damage** e.g. water pollution
- **To prevent damage to assets** e.g. building fire or machinery overheating

The Kitemark certification process ensures that your product safety integrity level (SIL) remains valid throughout its working life – from purchase, installation and maintenance. It does this by assessing the design and manufacturing inputs, including:

- **Quality management system**
- **Product design**
- **Software programming**
- **Product performance data**
- **Service and maintenance**
- **Process control**
- **Competence of key personnel involved in the process**

It also assures that your safeguarding products continue to be maintained effectively after installation and validates that they retain their SIL throughout their working life.

Functional Safety Kitemark assessment standard

The assessment standard series is EN 61508 – Functional Safety of Electrical / Electronic / Programmable Electronic Safety-related Systems (E/E/PE, or E/E/PES).

The standard has seven parts:

- Parts 1–3 contain the requirements of the standard (normative)
- Parts 4–7 are guidelines and examples for development and thus informative.

The assessment process validates the manufacturers capabilities and processes for producing products that meet the desired SIL throughout the sixteen phases of the safety lifecycle, which are roughly divided into three groups:

- Phases 1–5 address analysis
- Phases 6–13 address realisation
- Phases 14–16 address operation.

The Functional Safety Kitemark Certification Journey

In order to demonstrate your capability to work in compliance and achieve the Functional Safety Kitemark, here is what you can expect in five simple steps.

Step 1 Download your copy from the BS EN 61508 series

Download the appropriate standard from the BS EN 61508 series from the BSI shop here: shop.bsigroup.com. This is the standard you'll be assessed against and it contains all the requirements you'll need to meet to achieve the BSI Kitemark for Functional Safety.

Step 2 Complete your application

Contact our team to confirm your scope of assessment and start the assessment process. We'll assign you a Certification Manager, who will be your point of contact through the process – and beyond. Step 3 GAP Assessment to make sure you're on track

We carry out a gap assessment, of your documented system against the requirements of the standard and identify any omissions or weaknesses that need resolving before formal assessment. We also offer this a standalone option, if you are unsure about committing to certification at this stage.

Step 4 Formal assessment to achieve your BSI Kitemark

We'll conduct an assessment, the length and scope of which will be tailored to your specific requirements. As there is a wide range of activities, our assessment will vary from one organization to another. We'll also review your product to ensure it meets the requirements of the standard.

Step 5 Certification and beyond

Once the assessment has been successfully completed, we'll issue your BSI Kitemark certificate which can help grow your business.
