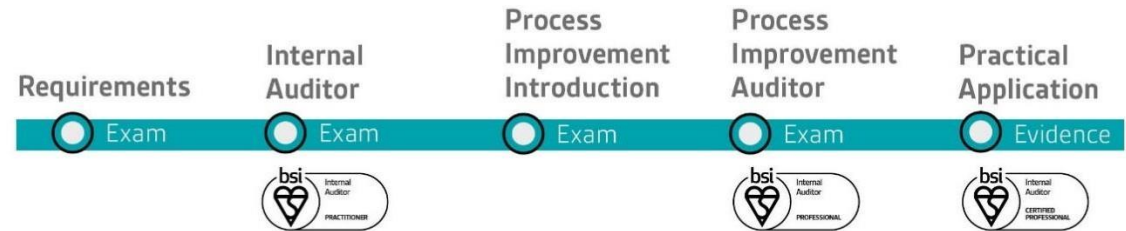

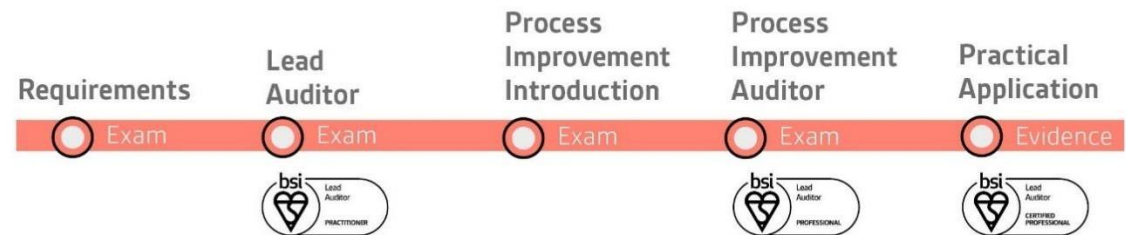

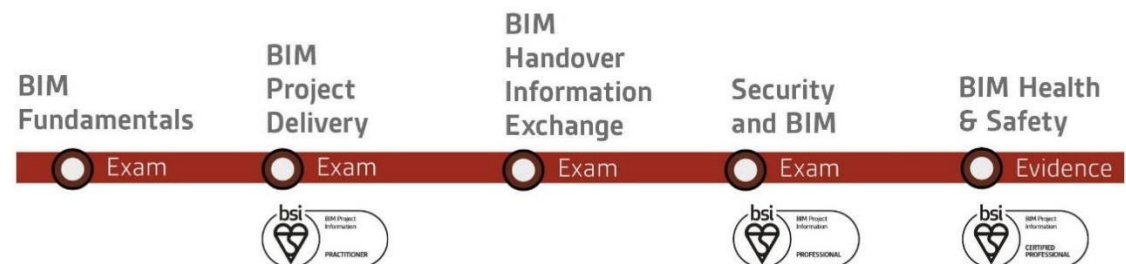
Lead Auditor
