MSPO certification benefits

Our Malaysian sustainable palm oil (MSPO) certification increases resilience across many parts of your business.

1. Social

- Change in mindset and attitude of staff and workers; better team work
- Better OHS risk management and reduction in workplace accidents
- Improved communication and relationship with workers
- More stable or loyal workforce; lower turnover rate
- Improved communication and engagement with smallholder, local communities and others stakeholders
- Enhanced productivity and well-being of associated smallholders
- Improved community relations though increased consultation and engagement

3. Governance

- More systematic documentation and access to information on operational and non-operational aspects, especially legal requirements
- Improved compliance of regulatory requirements

The Malaysian Sustainable Palm Oil (MSPO)

Endorsed by the Malaysian government in 2013, the Malaysian Sustainable Palm Oil (MSPO) Certification scheme helps increase the resilience of Malaysia's oil palm management and supply chain and applies to plantations, independent and organized smallholdings as well as palm oil processing facilities. Similar to programmes such as the Roundtable on Sustainable Palm Oil (RSPO) and Indonesia Sustainable Palm Oil (ISPO), MSPO aligns the management of palm oil production with many existing national laws and regulations.

MSPO 2530:2013 certification for oil palm producers

MSPO certification scheme allows for growers (independent or organised smallholders or estates) or palm oil mills to be individually or collectively certified. Group certifications may be a single certification covering:

- a group of estates
- a group of mills
- a group of smallholders
- a combination of an estate, mill and/or smallholders

MSPO certification enables organizations to declare their products as sustainable.

Benefits of certification include:

- Enhanced organizational reputations for being socially and environmentally responsible
- Facilitated access to the growing green market
- Supports significant growth and economic development opportunities for oil palm smallholders
- Ensures sustainable and equitable use of resources without negatively-impacting the environment or risking the health or safety of employees
- Compliance with Government of Malaysia directive on MSPO certification

MSPO Supply Chain Certification Scheme

Malaysian Sustainable Palm Oil Supply Chain Certification Standard (MSPO SCCS) was developed to deliver confidence and credibility to customers and end users that the palm oil they use in their products, businesses and homes is produced sustainably. Organizations can comply with MSPO SCCS through mass balance or segregation method with the relevant corresponding traceability attributes and declarations.

MSPO SCCS requirements focus on your organization's:

- Processes and procedures that make up its supply chain management system
- Resource management
- Traceability
- Supply chain model

MSPO SCCS applies MSPO Supply Chain Certification Standard (MSPO SCCS)

The MSPO standard is split into four parts. The first part applies to all organizations, but the following parts are specific to the size and type of your organizations:

1. general principles
2. general principles for smallholders
3. general principle for palm oil plantation and organized smallholders
4. general principles for palm oil mills

Each standard is based on the following principles:

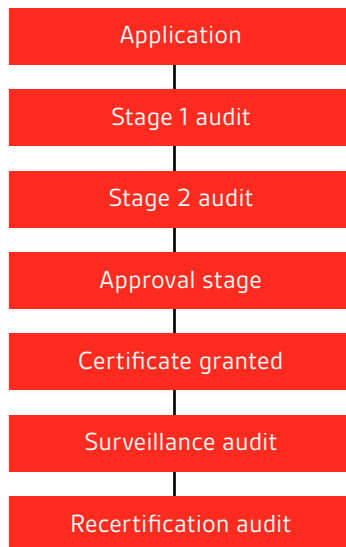
1. Management commitment and responsibility
2. Transparency
3. Compliance to legal requirements
4. Social responsibility, health, safety and employment condition
5. Environment, natural resources, biodiversity and ecosystem services
6. Best practices
7. Development of new plantings

Whether your organization met the mandatory deadline (31 December 2018 for RSPO-certified plantation industries, 30 June 2019 for non-RSPO-certified plantation industries or 31 December 2019 for smallholders) or still needs to certify, BSI's MSPO certification services can help.

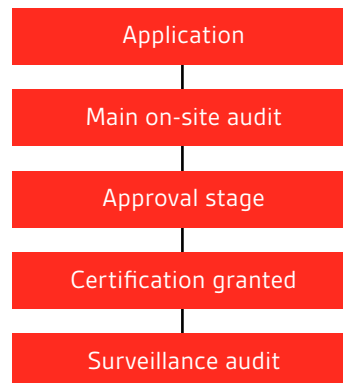
