Invitation to comment on RSPO Recertification Assessment of IOI Corporation Berhad - Ladang Sabah Palm Oil Mill and supply base, Sandakan, Sabah, Malaysia

IOI Corporation Berhad (RSPO Membership No: 2-0002-04-000-00) has appointed BSI to conduct RSPO Recertification Assessment of its Ladang Sabah Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 8 Oil Palm Plantations which are managed by the company. The certification unit is located at Sandakan, Sabah, Malaysia

BSI plans to conduct recertification assessment of Ladang Sabah Palm Oil Mill from 23rd until 26th January 2018. The recertification assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills (Revised 14 June 2017). The assessment will cover legal, environment, economical, workers’ health and safety, and social aspects as required by RSPO P&C.
