Invitation to comment on RSPO Initial Certification Assessment of Koperasi Serba Usaha Suka Makmur in Sumatera Utara Province, Indonesia.

Koperasi Serba Usaha Suka Makmur, an independent smallholder group under guidance of PT. Umbul Mas Wisesa, under SIPEF Group (RSPO Membership No.1-0021-05-000-00), has appointed BSI to conduct RSPO stage 2 initial certification assessment for its oil palm plantation. The independent smallholder located in Sumatera Utara Province – Indonesia.

BSI plans to conduct stage 2 initial certification assessment of Koperasi Serba Usaha Suka Makmur on 15 – 17th January 2018. The stage 2 initial certification assessment will be conducted against RSPO Management System Requirements and Guidance for Group Certification of FFB Production, March 2016 and RSPO Certification System, 2007. The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by RSPO P&C.
