Invitation to comment on RSPO Initial Assessment of FELDA Global Ventures Plantations (M) Sdn Bhd – Kerteh Palm Oil Mill & supply base - Ketengah Jaya, Terengganu, Malaysia

FELDA Global Ventures Holding Berhad (FGV) (RSPO Membership No: 1-0225-16-000-00) has appointed BSI to conduct RSPO Initial Assessment of its Kerteh Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 2 Oil Palm Plantation which is managed by FELDA Global Ventures Plantations (M) Sdn Bhd. The certification unit is located at Ketengah Jaya, Terengganu, Malaysia

BSI plans to conduct initial assessment of Kerteh Palm Oil Mill from 12 – 14 September 2018.
