**Invitation to comment on RSPO Initial Assessment of FELDA Global Ventures Plantations (M) Sdn Bhd – Kulai Palm Oil Mill, Kulai, Johor, Malaysia**

FELDA Global Ventures Holding Berhad (FGV) (RSPO Membership No: 1-0225-16-000-00) has appointed BSI to conduct RSPO Initial Assessment of its Kulai Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 1 Oil Palm Plantation which is managed by FELDA Global Ventures Plantations (M) Sdn Bhd. The certification unit is located at Kulai, Johor, Malaysia

BSI plans to conduct initial assessment of Kulai Palm Oil Mill from 19-21 September 2018. The assessment will be conducted based on the Malaysian National Interpretation of RSPO P&C for Sustainable Palm Oil Production: MYNI 2014 and RSPO Supply Chain Certification Standard – CPO Mills: June 2017.
