Invitation to comment on RSPO Recertification Assessment of Kulim (M) Berhad – Sedenak Palm Oil Mill, Kulai, Johor, Malaysia

Kulim (M) Berhad (RSPO Membership No: 1-0080-09-000-00 (Johor Corporation)) has appointed BSI to conduct RSPO Recertification Assessment of its Sedenak Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 4 Oil Palm Plantations which are managed by Kulim (M) Berhad. The certification unit is located at Kulai, Johor, Malaysia
