Invitation to comment on RSPO Recertification Assessment of Genting Plantations Berhad - Genting Oil Mills (Sabah) Sdn Bhd - Genting Sabapalm Oil Mill and Supply Base, Sandakan, Sabah, Malaysia

Genting Plantations Berhad with RSPO Membership No: 1-0086-06-000-00 has appointed BSI to conduct RSPO Recertification Assessment of its Genting Sabapalm Oil Mill and supply base. The assessment will be conducted at one (1) Palm Oil Mill and one (1) estate. The certification unit is located at Sandakan, Sabah, Malaysia.
