Invitation to comment on RSPO Re-certification Assessment of PT. Socfin Indonesia – Mata Pao Palm Oil Mill in Sumatera Utara Province, Indonesia.

PT. Socfin Indonesia – Mata Pao POM, an oil palm plantation company under PT. Socfin Indonesia (RSPO Membership No.1-0017-04-000-00), has appointed BSI to conduct RSPO re-certification assessment for its palm oil mill and supply base. The company located in Sumatera Utara Province – Indonesia.

BSI plans to conduct re-certification assessment of PT. Socfin Indonesia – Mata Pao POM on 18-19th February 2019.
