Dear Stakeholders,

This is to inform that Sakilan Palm Oil Mill under the Parent company IOI Corporation Berhad with RSPO membership number (2-0002-04-000-00) had appointed BSI Services Malaysia Sdn Bhd (“BSI Malaysia”) to conduct the Recertification Audit located at Sandakan, Sabah, Malaysia. The audit will be conducted from 11/11 to 14/11/2024 against the requirements of Malaysia National Interpretation 2019 of the RSPO P&C 2018 . The supply chain model is Identity Preserved.

IOI Corporation Berhad (IOI) is a leading global integrated and sustainable palm oil player. Their operations consist of the plantation business which covers Malaysia and Indonesia, while their downstream resource based manufacturing business includes refining palm oil as well as manufacturing oleochemicals and specialty oils and fats, which has a growing presence in Asia, Europe, and the USA.

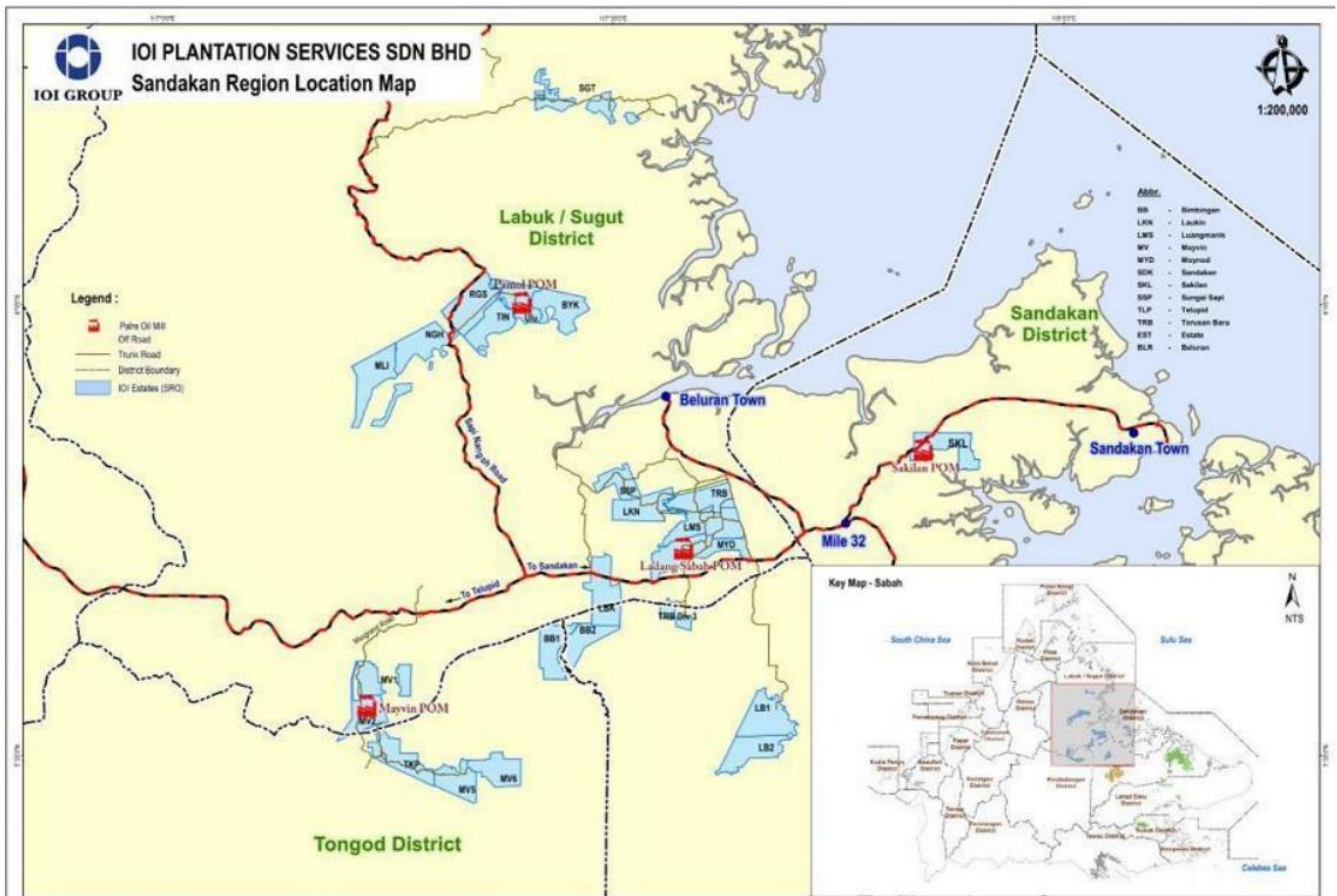
