Dear Stakeholders,

This is to inform that Numundo Mill under the Parent company SD Guthrie Berhad with RSPO membership number (1-0008-04-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Initial Certification Audit located at West New Britain, Papua New Guinea. The audit will be conducted from 19 - 23 August 2024 against the requirements of PNG & Solomon Islands National Interpretation 2019 of the RSPO P&C 2018 . The supply chain model is Identity Preserved.

SD Guthrie Berhad (previously known as Sime Darby Plantation Berhad) is a leading, vertically integrated global palm oil company. 
