## BS 99001 - Tackling quality management in the built environment

## Quality management is critical in the built environment sector, with significant implications for safety in both the short and long term.

The complex nature of the sector, which includes a diverse range of organizations, encompasses multiple disciplines and operates through a wide range of contract and project types.

This complexity, along with regulatory drivers and a move towards more integrated approaches to management systems to build environmental, economic and social sustainability, heightens the needs for a more sector-specific approach to known and predicted issues.

BS 99001 aims to address quality management issues that are prevalent in the built environment sector with significant implications for safety in both the short and long term, and to focus on good quality management within the industry.

### What is BS 99001?

A Quality Management System (QMS) standard that builds on ISO 9001, but is specifically developed for the Built Environment sector.

- **Positions quality alongside sector requirements** for continuous improvement, including the golden thread, supply chain and life cycle of built assets
- **Supports the industry** to implement requirements of the Building Safety Act 2022 within the UK, as well as other emerging legislation around building safety
- Acknowledges multi-organizational, projectbased ways of working, and provides clarity in interpretation of QMS requirements in the context of the sector
- Includes expanded requirements to those in ISO 9001 which are key to the built environment sector (e.g. competence, design quality, temporary works, inspection and test plans and documented information)

BS 99001 has been written for the benefit of the whole sector globally.




