In order to demonstrate your capability to work in compliance with ISO 19650 and achieve the BIM Design and Construction Kitemark, here is what you can expect in six simple steps.

#### Step 1 Download your copy of ISO 19650

Download ISO 19650 from the BSI Shop, here: **bsigroup.com/BIM-standards-uk**. This is the standard you'll be assessed against and it contains all the requirements you'll need to meet to achieve the BSI Kitemark for Asset Management.

#### Step 2 Complete your application

Contact our BIM team to confirm your scope of assessment and start the assessment process. We'll assign you a Certification Manager, who will be your point of contact through the process — and beyond. They'll have an excellent understanding of your business area and will support you as you move forward to assessment and certification. #### Step 4 GAP Assessment to make sure you're on track

#### Step 5 Formal assessment to achieve your BIM Kitemark

We'll also review a sample of your live and completed BIM projects to ensure they meet the requirements of the standard.

#### Step 6 Certification and beyond

We will then be conducting surveillance visits on an annual basis, to review any changes to your BIM content and processes and to ensure you continue to meet the latest standards.


