

Why does UKCA exist?

Brexit | 01-01-2020

After the 'hard Brexit' the UK no longer uses the CE marking system. UKCA marking is announced including a transition phase.



Transition phase

During the transition phase CE and UKCA marking are both accepted for products that are supplied to the UK.

UKCA marking <u>can</u> be affixed



Deadline UKCA marking | 01-01-2023

As from first of January 2023 UKCA marking is obligated for exporting most products to the UK that need a marking.

UKCA marking <u>must</u> be affixed

Changes per 20-06-2022

Changes affect the following regulations that BSI provides Approved Body services for:

- Gas appliances regulation
- PPE regulation
- Radio equipment regulation
- Measuring instruments regulation
- Pressure equipment regulation
- Lifts regulation
- Eco design and energy related products regulation (previously boiler efficiency directive

Our interpretation:

Existing CE Module B, Type Examination remains valid for UKCA marking.

FPC audits / Surveillance audits remain a requirement.

CE type examination remains valid after 31-12-2022 until 31-12-2027, until the expiry of the certificate or until the product is changed. Whichever comes first.



Construction Products Regulation

- All AVCP 3 notified laboratory testing done before 31-12-2022 is now accepted until the product changes or the standard does.
- AVCP 1, AVCP 1+ or AVCP 2+ remain unaffected.
 Transition to a UK Approved Body still needed before 31-12-2022.

- Outdoor noise
- Eco-design
- Aerosols

Products covered by the UKCA marking but have some special rules

- Medical devices
- Rail interoperability
- Construction products
- Civil explosives




Subcontracting agreement with current Nobo
