It is critical to work with an EU Notified Body or UK Approved Body that understands the industry and has the experience to review and confirm your product's readiness for market.

Notified Body - BSI The Netherlands (2797) - reviews medical devices to ensure their conformity to the European Directives and Regulations.

Approved Body - BSI UK (0086) - provides conformity assessments under the new UKCA Scheme.

Raising awareness for food poverty

In June, BSI's Regulatory Team took part in a 12 hour fast to raise awareness for food poverty. This is just one of many initiatives we have planned globally.

According to the most recent estimates by the UNSDG, in 2015, **10%** of the world's population, (or **734** million people) lived on less than **\$1.90** a day.



As a team, we not only wanted to raise funds to help combat this shocking figure, but we also wanted our team to experience the hardship of food poverty first hand, in order to help us all make more sustainable choices going forward.

As well as many of our colleagues donating the food they saved to their local food banks, we also raised just under **£1,000** for The Trussell Trust, who support a UK nationwide network of food banks to help

provide emergency food and support to people locked in poverty, as well as campaigning for change to end the need for food banks in the UK.
