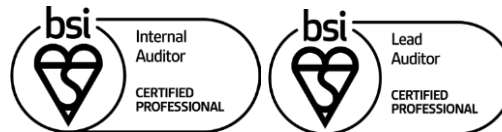

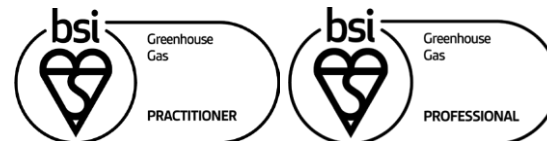

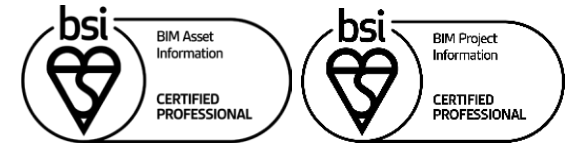
Greenhouse Gas Qualifications

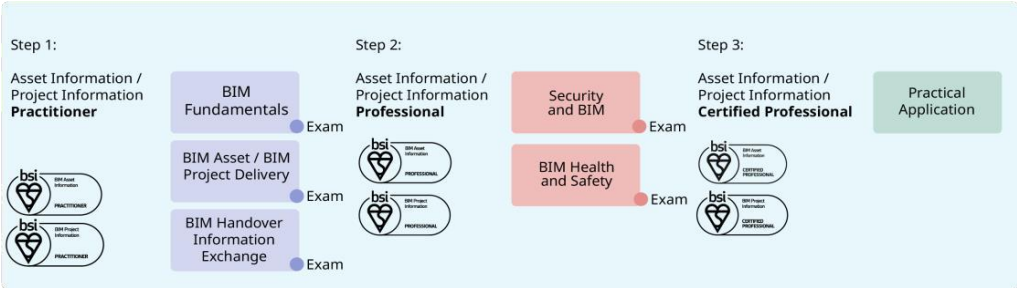
