## The Standards Challenge Fund

Innovation moves fast, but confidence, trust, and consistency are what enable new ideas to succeed. Standards play a vital role in bridging this gap. They capture agreed best practices, align expectations across the value chain, and empower innovative businesses to demonstrate a commitment to quality that builds lasting trust in products and services.

The **Standards Challenge Fund (SCF)** gives small and medium enterprises (SMEs) a stronger voice in shaping the standards that will influence tomorrow's markets. Delivered by BSI in partnership with Innovate UK, the programme began by inviting SMEs to submit ideas for standardization in areas where shared guidance and common approaches could accelerate innovation and drive growth across the UK economy and society.

Following a rigorous review of a high volume of submissions, four ideas were selected for development into standards, aiming to address emerging challenges across three critical themes: Digital and technology, net zero, and healthy living and ageing.





# From ideas to trusted best practice

Each selected idea is currently being developed into a **fast-track standard** with the original submitters continuing to play an active role alongside a wider community of industry contributors.

This approach will help ensure the resulting standards are:

- **Practical:** rooted in real-world commercial realities and implementation challenges.
- **Informed:** developed directly by those building and using innovative solutions.

These projects span across sectors - from GenAI agents and DNA barcoding to recycled plastics and RF-powered wearables.
