

Single Copy PDF Purchases

Individually licensed standards require separate purchases for each user and each standard. This approach can lead to inefficiencies and higher costs. Key considerations include:

1. Access Restrictions

- Limited to one user per license—no sharing or copying allowed.
- Additional licenses must be purchased for each additional user.

2. High Per-Document Costs

- Each standard costs approximately £100 per user (BSI Member rate).
- Example: 5 people needing access to 10 standards costs £5,000 annually.

3. Manual Tracking of Updates

• Staff must dedicate time to monitor updates and revisions manually.

4. Time-Intensive Gap Analysis

• Identifying changes between old and new versions is labor-intensive.

5. Procurement Complexity

• Requires multiple purchase orders and coordination with finance for every standard.

6. Audit Preparation Challenges

• Manual tracking increases administrative burdens and risk of non-compliance.
